- Make sure the class you sign up in is covered by your sanctioning body
- Riding below classification is cause for disqualification
- All Trail — No Roads

- Approximately 65 miles
- Restart format with possible speed changes
- Rideable for novice, challenging for "A" riders
- FTR or SE&TRA and AMA memberships required (available at signup)
- Pre-entry may request row (drawing September 30th)
- Post-entry starting position (random drawing)
- Entries mailed together may ride together

Inspection requirements for Enduro:

\$20.00 Forestry Permit, lights, and spark arrestor

Starting area/gas stop/finish are all inside the Croom Cycle Park at the Withlacoochee State Forest. The entrance is located at the Northwest corner of I-75 and SR 50/US 98 (Exit 301). Campsites with full facilities available at the starting area on a first come, first served basis (\$12 with electric, \$10 without).

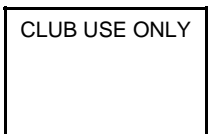

The course is dangerous. Not all obstacles may be marked, so ride carefully.
