- 3. A proposal was made to move Vet A, B, C to the Sunday afternoon race. This proposal passed a 2nd vote in the harescramble committee meeting. Motion: George 2nd: Randy F Approved: 9 for 4 Against
- 4. Approve 2022/2023 Schedule Motion: Kelsey 2nd: Kayla Approved Unanimously
- 5.The current Tie-Break system for Enduros no longer fits the setup of the races today vs when the Tie- Break was voted in. This past racing season, COVID year and only 4 Enduros counted toward end of year awards, 4 class ties existed. The current Tie-Break system is going outside the class and uses overall race placement. This seems unfair in that other riders in different classes can determine a class winner for the year.
