## INSTRUCTIONS

- This event is sanctioned under and will be governed by the competition rules set forth by the Competition Congress of the American Motorcycle Association, Westerville, OH 43081.
- Membership in the American Motorcycle Association is required for all riders. You must have a plastic membership card in your possession or a valid receipt showing that you have joined or you must join. Also, SERA, SETRA or FTR membership is required, one day memberships will be available.
- Motorcycles must be equipped with a muffler/silencer that does not omit noise louder than 10 DB at 20 inches... (110 for 4 Strokes). Approved spark arrestors are required on all exhaust systems. Muffler must be

- securely attached and permanent or you will not be allowed to start.
- Riding positions will be determined on a first received basis. SERA, SETRA and FTR members may request a row number for himself and/or other SERA/SETRA/FTR members. This request must be in writing, be accompanied by completed entry forms and payment. Row request will not be granted over the phone. Please do not try. Five riders per row.
- No row assignment changes or refunds. You may not ride on another entrant's row or fee.
