Vice President's Report

- 1. Discussion continued from the previous BOD meeting regarding investing the land use fun rather than having it remain in a checking account.
- Michael Relyea of Merrill Lynch (FTR member and advertiser) was introduced by James Hill and spoke regarding the various options available to keep the funds along with the various risks.
- Discussion continued with a motion tabled for new business.

Treasurer's Report

- 5. Joe Carrasquillo mentioned that the Alligator Enduro would be a National the last weekend in February 2018. Extensive discussion regarding this being a conflict with the CFTR enduro and the difficulty scheduling events. Joe stated Daytona Dirt Riders (DDR) does not want to cause a problem for FTR events. The Alligator enduro will not be an FTR sanctioned event if there is a conflict.
